### 隐私政策

We Are Social竭力保护您的个人隐私和信息安全。你可以浏览本网站的大部分内容,而无需向我们提供任何可以识别你的个人信息。然而,有时我们需向您收集额外信息,以向您提供您所期待从We Are Social获取的信息或服务。我们希望通过本隐私政策向您说明我们可能会收集的信息、我们如何使用这些信息以及将如何保护这些信息的安全等。

您使用或继续使用我们的网站或软件服务,都表示您同意我们按照本隐私政策收集、使用、储存和分享您的信息。

- 1. 我们可能收集的个人信息类型:
  - (1) 在职位申请过程中主动提交的个人相关信息:

### 6. 我们如何处理未成年的个人信息

- (一)我们重视未成年人个人信息的保护,我们的产品、网站和服务是面向成人的,如果没有父母或监护人的同意,我们将不向未满18周岁的未成年人提供任何服务。
- (二)对于经父母同意而收集的未成年人个人信息的情况,我们只会在受到法律允许、父母或监护人明确同意或者保护未成年人所必要的情况下使用或公开披露此信息。
